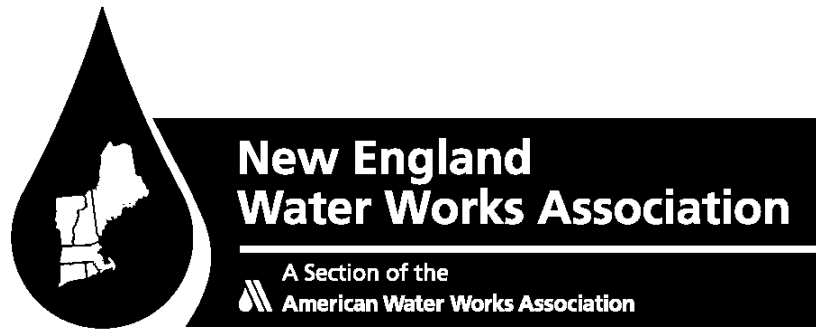

LIST OF BACKFLOW PREVENTION DEVICE INSPECTORS/TESTERS

Attached is a list of individuals who are currently certified by New England Water Works Association as Backflow Prevention Device Inspectors/Testers.

The purpose of these documents is to provide a list of individuals who currently hold a valid NEWWA certification. This document is for information purposes only and not to be used for solicitation purposes. The list is organized by state for simplicity and is based on address information either work or home. The list is sorted alphabetically by last name within each state.

New England Water Works Backflow Prevention Device Inspector/Tester Certification, and Cross Connection Control Surveying Certification are universally recognized. However, some states such as but not limited to: Massachusetts, Connecticut, and New York require individuals to be state certified. Individuals listed in a particular state may not be certified to test backflow prevention devices or perform cross connection control surveys in that specified state without state certification. Other states do not have a separate state certification and accept NEWWA certification. Check with the states' drinking water program or plumbing code for further information regarding certification requirements.
