Dear NEWWA, a Section of AWWA Membership:

On April 26, 2023, after much consideration and overwhelming support from the membership (92.5% in favor of, versus 7.5% against, per the straw poll taken on April 6, 2023), the NEWWA, a Section of AWWA Board of Directors has voted to officially disaffiliate from the American Water Works Association (AWWA), effective June 20, 2023 (the anniversary date of the Affiliation Agreement's original signing on June 20, 2010).

**What this means for you as a NEWWA, a Section of AWWA Member:**

As a NEWWA, a Section of AWWA member you are also a member of NEWWA, Inc. per current governing documents. NEWWA, Inc. will continue to honor your current membership and accompanying benefits until your next renewal date.

***At the time of your next renewal, you will have one of three options (more info. to come):***

- 1. Retain membership in BOTH AWWA and NEWWA, Inc. and receive benefits of both organizations.***
- 2. Choose to renew with just NEWWA, Inc. and receive ONLY NEWWA, Inc. benefits.***
- 3. Choose to renew with just AWWA and receive ONLY AWWA benefits.***

### **What Types of Changes Will We See?**

NEWWA, Inc., members will see updated branding—we're getting a new look! Other than that, members will see very little change in how we operate. Our symposia, membership meetings, and conferences are here to stay, along with our accredited training program and full staff team. In addition, members will continue to receive the *Journal of the New England Water Works Association, Inc.*, as well as *The Source* and *Currents* member newsletters, and NEWWA, Inc.-specific emails like the E-Source and training program emails.

NEWWA, Inc. will no longer facilitate AWWA member recruitment, or AWWA competitions, awards, or scholarships.

### **Will AWWA and NEWWA Work Together Again?**

While NEWWA, a Section of AWWA is disaffiliating with AWWA from an official legal and business operations standpoint, that does not mean the two organizations cannot continue to partner on important initiatives and issues, like advocating at the Washington, D.C., level on regulations and legislation. We have simply determined that the changes AWWA wanted to enforce on the business relationship and previously approved governance structure that existed successfully for 35 years were not viable.
