9:30 AM "Successes With Regional Water System Planning and Implementation in New Hampshire for 700,000 People"

MIKE UNGER, Water Engineer, New Hampshire Department of Environmental Services & BRIAN GOETZ, Administrator, Rye Water District, Rye, NH

Recently, NH has put a greater emphasis on regional water system planning to meet long-term water supply needs and to support emergency planning. The initial phases of the Regional Water Projects in Southern New Hampshire have been completed and additional phases are in progress. The Seacoast Emergency Water Interconnection Study developed in 2025 supported planning for emergency mutual aid and small system consolidation. This presentation will discuss the success (and challenges) of these two regional initiatives funded by NHDES.

11:00 AM "Evaluating the Unintended Benefits and Consequences of GAC Treatment"

HENRY HOOD, Project Engineer, Underwood Engineers, Portsmouth NH

Emerging PFAS contamination and evolving EPA regulations have prompted significant response across New England. While granular activated carbon (GAC) is widely recognized for its effectiveness in removing PFAS, there is more attention being paid to potential impacts on other water quality parameters—some challenging and others helpful. This presentation highlights findings from UNH MEng research paper on formation potential of disinfection byproducts (DBPs) prior to and following GAC treatment at the Dover, NH Pudding Hill Water Treatment Facility.
