Emerging contaminants such as PFAS and manganese continue to challenge drinking water management. The Rhode Island Department of Health is advancing work in the emerging contaminants space through expanded PFAS sampling and a statewide manganese vulnerability study. This presentation will highlight Rhode Island's approach, key findings to date, and practical implications for water systems.

1:20 PM From Records to Inspections to Results: East Providence's GIS-Centric Approach to LSL Inventory

East Providence Water Utilities Division has taken a comprehensive, data-driven approach to lead service line (LSL) inventory development, leveraging exceptionally detailed and well-organized historical records, a 9,000-meter replacement program to inspect private-side services, and targeted grant funding to investigate 1,600 additional locations. Presented by Mary Samar of EPIC, this session highlights how coordinated partnerships and a well-structured GIS strategy have enabled EPW to minimize unknowns and build a robust, defensible inventory.

Advanced Metering Infrastructure (AMI) offers significant benefits for water utilities, selecting the right system requires careful planning and procurement. This presentation demonstrates how engineering consultants guide utilities through a Qualifications-Based Selection (QBS) process to define requirements, evaluate technologies, and implement AMI with complete meter replacement. A case study from the Woonsocket Water Division highlights real-world outcomes, including acoustic leak detection. This presentation provides practical insights on procurement and implementation of AMI systems that deliver long-term operational and customer service benefits.
